The Golden visa is a long-term residence permit that grants international talent access to exclusive benefits while allowing them to live, work, or study in the UAE. The Golden Visa is open to investors, entrepreneurs, scientists, outstanding graduates, humanitarian pioneers, and frontline heroes. This visa was issued with the intention of keeping "talented people and great minds" in the country. The residency enables visa-free travel to all seven Emirati states.

As a long-term residency program, His Highness Sheikh Mohammed bin Rashid Al Maktoum, Prime Minister and Ruler of Dubai, introduced the UAE golden visa in 2019. The visa has been granted to over 1,000 investors, businessmen, and some of their families since its launch.

You must demonstrate that you have invested at least AED 2 million (approximately US\$550,000) in order to be eligible for the UAE Golden Visa. You can get a golden visa for ten years as a result of the investment, which is in real estate.

The processing time of UAE Golden Visa is typically 2 to 3 months.


- The United Arab Emirates Golden Visa applicants are not required to take language, history or culture exams.

STEP 3: MONTH 7-9
