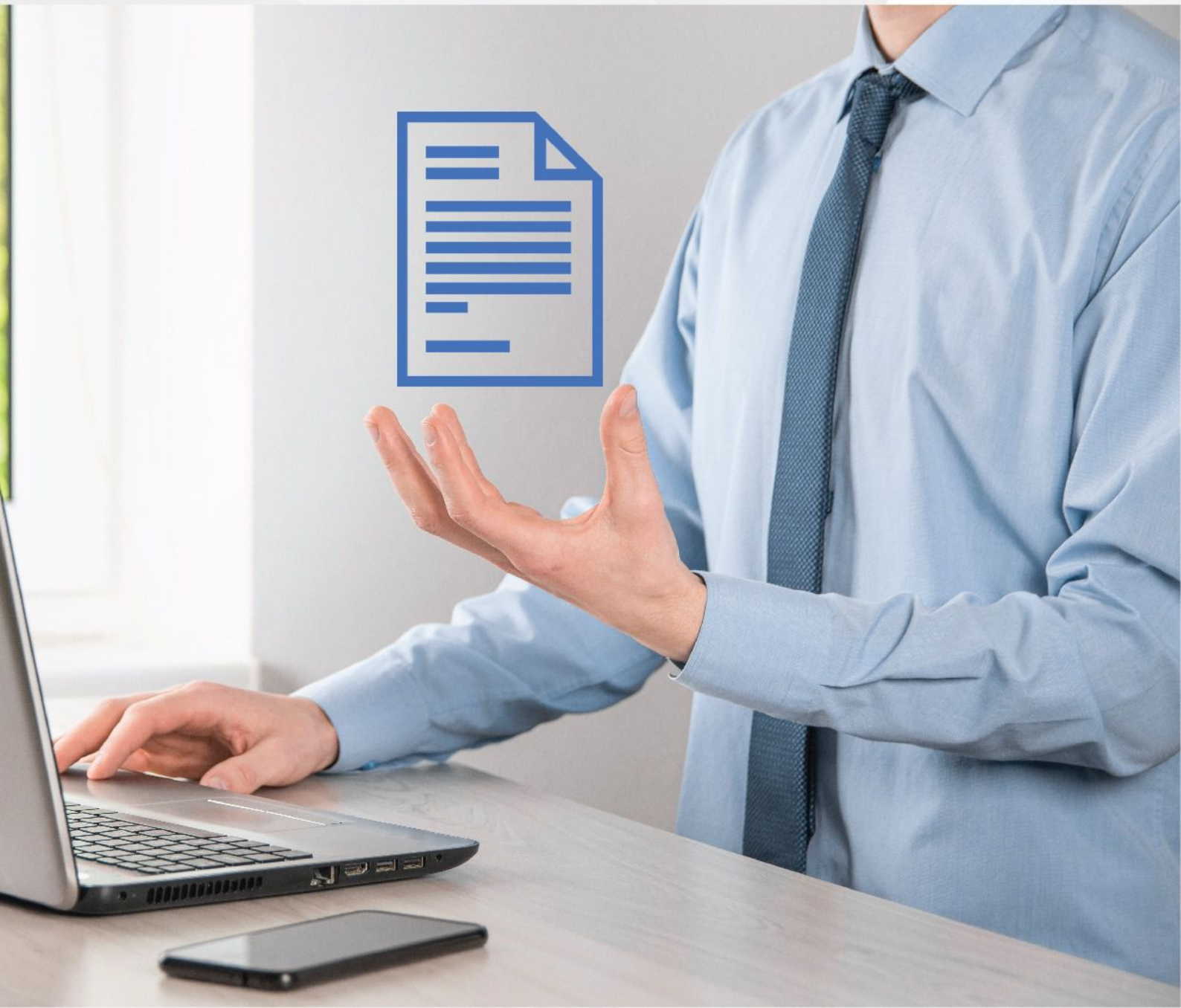
To meet all requirements for USA EB-5 visa you should put US\$800,000 in another business venture that creates 10 full time positions for US workers.
